 - > Summer Stipend (lump sum, subject to tax withholdings)

PhD Funding Overview – Additional Resources

- ➤ Guaranteed Columbia housing for five academic years
- > Full health insurance coverage on the student plan for eligible dependents
- ➤ Health insurance coverage while on an official <u>medical leave</u>
- Subsidy towards optional dental insurance plan
- Accommodation for Parental Responsibilities
- ➤ <u>Child-care subsidy</u>
- Funding to attend conferences
- GSAS International Travel Awards
- > Coverage of Internet fee for students in <u>university housing</u>
- Printing quota upgrade when not on appointment
- Gym access during funding-eligible years



Your Responsibility

- > Rent
- > Student Activities Fee: \$46 each semester
- > Document Fee: \$105 one-time, first semester
- ➤ Language and Other Course Specific Fees
- ➤ Late Registration Fee: \$100
- ➤ Late Payment Fee: \$150 (first assessment), 1.5% of balance monthly
 - > if related to any of the above categories or during self-funded semesters
- ➤ Withdrawal Fee: \$75



Registration – Enrollment Categories

- > Two Residence Units (RU) are required for the MA earned as part of a PhD degree
- ➤ Four additional Residence Units, for a total of six overall, are required for conferral of the MPhil, PhD, and DMA degrees.
- ➤ These six Residence Units correspond to the first three years of a PhD program.

Enrollment Categories:

RU = Full Residence Unit (first six semesters of enrollment)

After completing required RUs (typically in your fourth year):

- > ER = Extended Residence
 - > Register for a course
 - ➤ Hold a university teaching or research appointment
- ➤ M&F = Matriculation and Facilities
 - > completing a degree requirement such as a language examination or qualifying examination
 - > Preparing, writing, or distributing the dissertation proposal or dissertation



Next Steps - Complete As Soon As Possible

- > Apply for a Social Security Number
 - ➤ https://isso.columbia.edu/content/social-security-number-application
- > Open a U.S. bank account
 - ➤ https://isso.columbia.edu/content/resources-students
- > Resolve any outstanding HOLDS on your Columbia University account
 - > Immunization hold will prevent registration and disbursement of your funding
 - ► https://www.health.columbia.edu/immunization-compliance-office
- > Provide visa information to payroll team
 - > Our office will be reaching out with additional details in July



Next Steps - Complete by Friday, August 23rd

(or as soon as possible after arrival)

- > Update your address in Student Services On-Line (SSOL)
 - ➤ Must have a U.S. address on record for LOCAL address
 - ➤ Must have a FOREIGN address on record for PERMANENT address
 - ➤ NOTE: Your permanent address should remain as a foreign address unless your citizenship changes
 - ➤ Log into <u>SSOL</u> (ssol.columbia.edu)*
 - ➤ Select Addresses: View and Update
 - ➤ Click Update under the Local Address section to make any changes

> Enroll in Direct Deposit

- > Must use a U.S. bank account
- ➤ https://www.sfs.columbia.edu/direct-deposit
 - ➤ Complete FIRST option for Refunds/Stipends



Next Steps – Register for Fall 2024 (3-day window!)

- > Registration will be available via SSOL for the following dates:
 - ➤ Tuesday, August 27th
 - > Wednesday, August 28th
 - ➤ Thursday, August 29th
- > Enrollment Category = RU (Residence Unit)
 - You must register for a RU and at least ONE course prior to the end of registration on Thursday, August 29th

Funding Disbursement Process -- International

Funding Added to Financial Aid

- Local Address in SSOL
- Direct Deposit Enrollment
- Registration in Enrollment Category
- HOLDS must be cleared (Immunization)
- Social Security Number



No Enrollment Category!

- Tuition and Fees Covered
- Stipend Funds Transferred to Payroll for Tax Withholding Processing
- Visa information must be in place for continuation of disbursement process

Stipend Processed to Student

- Payroll
 Processing
 Occurs Semi monthly
 (roughly every
 two weeks)
- Direct Deposit (3-5 business days from Payroll process date)
- Paper Check (10-14 business days)



September 13 is the first payroll process date for Fall 2024. Students who have all steps completed by priority deadlines will be included in the first process.

Takeaways

- > Take action now or as soon as possible
 - ➤ Apply for SSN, Open a US bank account, Clear HOLDs, Update address and enroll in Direct Deposit
- > Importance of Enrollment Categories
 - ➤ Register for RU between August 27 29 (and at least one course)
- > Your People are HERE
